- Similar confirmation from Senate Permanent Subcommittee on Homeland Security - ERHC has fully satisfied subpoenas and no further action being taken










Joint Development Zone

Financial Matters



• Through Q1 2012

- Through December 31, 2011, ERHC had cash, cash equivalents and treasury bills totaling \$11.9 million
- The Company has virtually no debt
- During the first quarter, ERHC's G&A expenses totaled \$1.04 million
- G&A expenses decreased approximately 15 percent from the first quarter of fiscal 2011
